Sources of Preventive Visit Data for Adolescents & Young Adults

July 2023



This document provides the most up-to-date information on major national data sources that assess preventive visit receipt for adolescents and young adults in the United States.

It describes key features of data sources, including respondent, wording of preventive measure, and availability of online data analysis tools. The document provides opportunities for monitoring and analysis of preventive visit receipt by adolescent and young adult populations. We also provide information about data sets that formerly provided preventive visit data and/or may in the future and whether data is accessible through an online query system.

This document was produced by the Adolescent and Young Adult Health National Resource Center and the Adolescent and Young Adult Health Research Network, based at the University of California, San Francisco.
